#### **Unfinished Business**

- Amendment to the bylaws regarding the budget approval deadline was brought back onto the table. Motion passes.
- Amendment to the Constitution regarding Senate duties regarding the budget was brought back onto the table. Motion passes.

#### **New Business**

- Motion: Vice President Sarah Angell motioned to create an Ad Hoc Recruitment Committee. It was seconded by Sigma Sigma Sigma. Discussion: Angell expresses the committee will further tasks and membership within SGA. Motion passes.
- Motion: Vice President Sarah Angell moves to amend the bylaws to say the President serves as an ex-officio member of all committees and commissions of the SGA; except in circumstances when serving on specific a committee will create a conflict of interest, such as running for re-election. It was seconded by Sigma Sigma Sigma. Discussion: This amendment will allow for exceptions for conflicts of interest in committees. For example, President was an ex-officio of the election committee, they could not run for re-election for office.
  - o A motion was made to table this until the next Senate meeting. Motion passes.
- Motion: Chief Arbiter Zoey Shamblin makes a motion to amend Article IV of the SGA Bylaws under the Student Conduct Branch. This motion will bring the Chief Arbiter voting rights of the Senate and allow the Judicial Liaison to vote in the second or absence of the Chief Arbiter to align the Bylaws with the Constitution. This will ensure the consistency of Bylaws and the Constitution providing clarity on the voting rights of Chief Arbiter and the Judicial Branch. It was not seconded. Discussion: More clarity between the Constitution and Bylaws of Judicial Liaison and Chief Arbiter.
  - o Motion made to table by Delta Zeta. Motion passes.
